The Southgate Community Fund (SCF) is an opportunity to support the projects and programs of non-profit organizations and charities in the Township of Southgate. The fund was created in 2021 through contributions from the Southgate Solar and the Eco-Park Royalties Funds as a permanently endowed community fund.

Donations to the SCF are invested and managed by Community Foundation Grey Bruce (CFGB). CFGB distributes the income earned from the capital of the Fund through grants to applicable non-profit organizations within the Township of Southgate. Local applications will be reviewed by the SCF Review Committee and the CFGB Review Team.
