


2026 FINANCIAL FORECASTING RESIDENT SURVEY

- Results will help guide budget priorities by providing insight into what residents value most




Overview

- Survey Period: September 18 October 18, 2025
- There were 90 respondents in total which is a vast improvement from previous years where feedback and engagement numbers were below 20

Demography of Respondents


Which of the following describe your connection to the Township? Please select all that apply.




How many years have you lived in the Township of Southgate?


What is your age?


Demography of Respondents Summary

- Majority of our respondents were early middle age 35-44; late middle age 55-64 and seniors, 65+
- > 98% rent or own property in Southgate
- > 48% have lived here over 10 years, 33% for 2-10 years, 17% under 2 years
- > 90% learnt of the survey online (Township website + subscription news and social media)


5. How familiar are you with how the Township develops its annual budget?

Awareness of the Budget Process Summary

- o 46% of respondents are unfamiliar with the budget process, 42% are somewhat familiar, only 11% are familiar with the process and 1% has no interest.
- Our respondents are primarily interested in the following 3 areas:
 - What services do I receive for my tax dollars?
 - What is the breakdown of what my tax dollars are put toward?
 - How does the Municipal Property Assessment Corporation (MPAC) calculate the property's current assessment?
 - Residents desire simpler and more accessible information on how their tax dollars are used.

Improved, even if it means a tax increase


Maintained, with only an inflationary increase to taxes







Community Services Summary

Of the 16 service areas, the respondents only wish for Physician Recruitment & Healthcare Engagement to be improved.

All other services are to be maintained.

Noteworthy also, are the views on Land Use Planning: 42% wish it to be maintained, while 33% want it reduced.

Community & Recreation Programs - have equal calls for improvement and maintenance

Overall, majority respondents support Physician Recruitment and Healthcare System Engagement being improved, while all other services are maintained with only modest tax increases resulting from inflation.
